"GLOBAL" is a topical quarterly for political and economical issues, published by the OHRID Institute for Economical and International Affairs. The Editorial Board of "GLOBAL" announces an open call for papers for the second edition of the magazine, on the general topics:

- Political development
- Economic perspectives

We would like to point to the potential authors that the topic can be approached in different contexts, in its Macedonian, regional or global dimension.

The goal of this magazine is to become an intellectual voice on the current issues of international economics and economic policy based on comprehensive and in-depth analyses, with a primary focus on Macedonia. Emphasis is placed on identifying key issues at the time - spanning international trade, international finance, the environment, energy, the integration of regional economies and other issues - in order to furnish ideas and proposals to contribute positively to the policy debate in the country and the region.

The magazine will provide a forum for discussion, debate and the refinement of key ideas in this field.

"GLOBAL" is dedicated to publishing the highest quality research in any field of economics and politics, without prejudice to the methodology or to the analytical techniques used. The editors encourage submissions in all fields of economics and politics in order to provide practical contributions to the literature, and to further the influence of economics in the world of practical affairs.

All interested need to submit a short proposal (300-500 words), short biography and a list of bibliography to the Editorial board, by October 31st, 2007 at the latest. The deadline for submitting the final version of the selected proposals is 07th of

November, 2007. Proposals and final texts can be submitted in Macedonian and English language.

Please follow the manuscript guidelines enclosed.

Although not strictly limited to them, please observe the following guidelines:

In case of submitting theoretical papers, please include: abstract, introduction, extensive literature review, theoretical implications, conclusion and bibliography.

In case of submitting empirical papers, please include: abstract, introduction, short literature review, methodology, empirical findings, conclusion with policy implications and bibliography.

Format:

- Length of the texts: 1,500 -2,500 words
- Font: **Times New Roman** - English or Macedonian language (Cyrillic encoding)
- Spacing: 1,5
- Referencing Style: Footnotes - [The Chicago Manual of Style \(CMS\)](#) - (available in the attachment as well)
- Tables, graphics, statistical data and other visual objects need to be referenced in the body of the texts under the table, graphic, etc and in accordance with [CMS](#)
- Each text needs to have an abstract in English in between 150-200 words that will give a short overview of the content and key issues in the text
- Each text needs to have 3-5 key words that best portray the essence of the theme
- Each text needs to have a bibliography in accordance with [CMS](#)
- Each author needs to submit a short biography. The biography should be submitted in a separate file, in order to assure full anonymity during the process of selection and evaluation of the texts by the editorial board.

The editors and publishers of "GLOBAL" are not responsible for any cases of plagiarism or breaches of copyrights or other intellectual rights that may arise in any of the published texts. The authors of the texts are responsible for acquiring copyrights and other similar permissions.

All papers will first be considered by the Editorial Board for general relevance and significance and for its suitability to the profile of the periodical.
