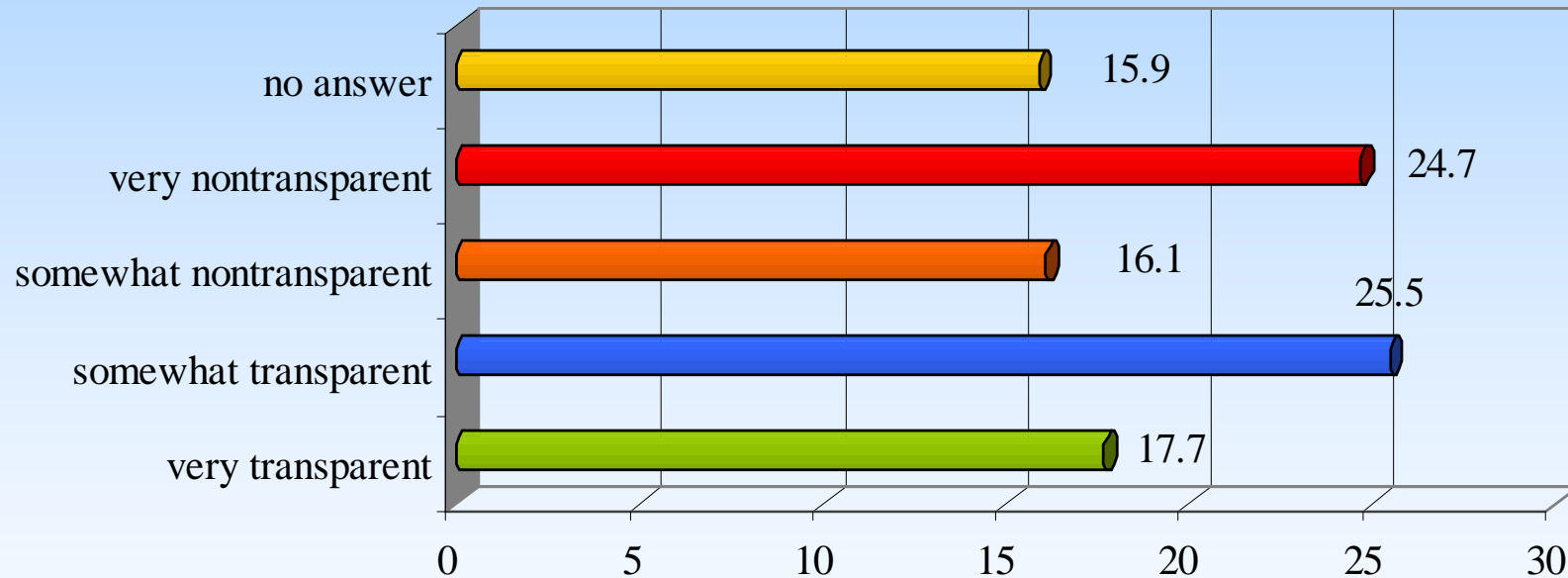

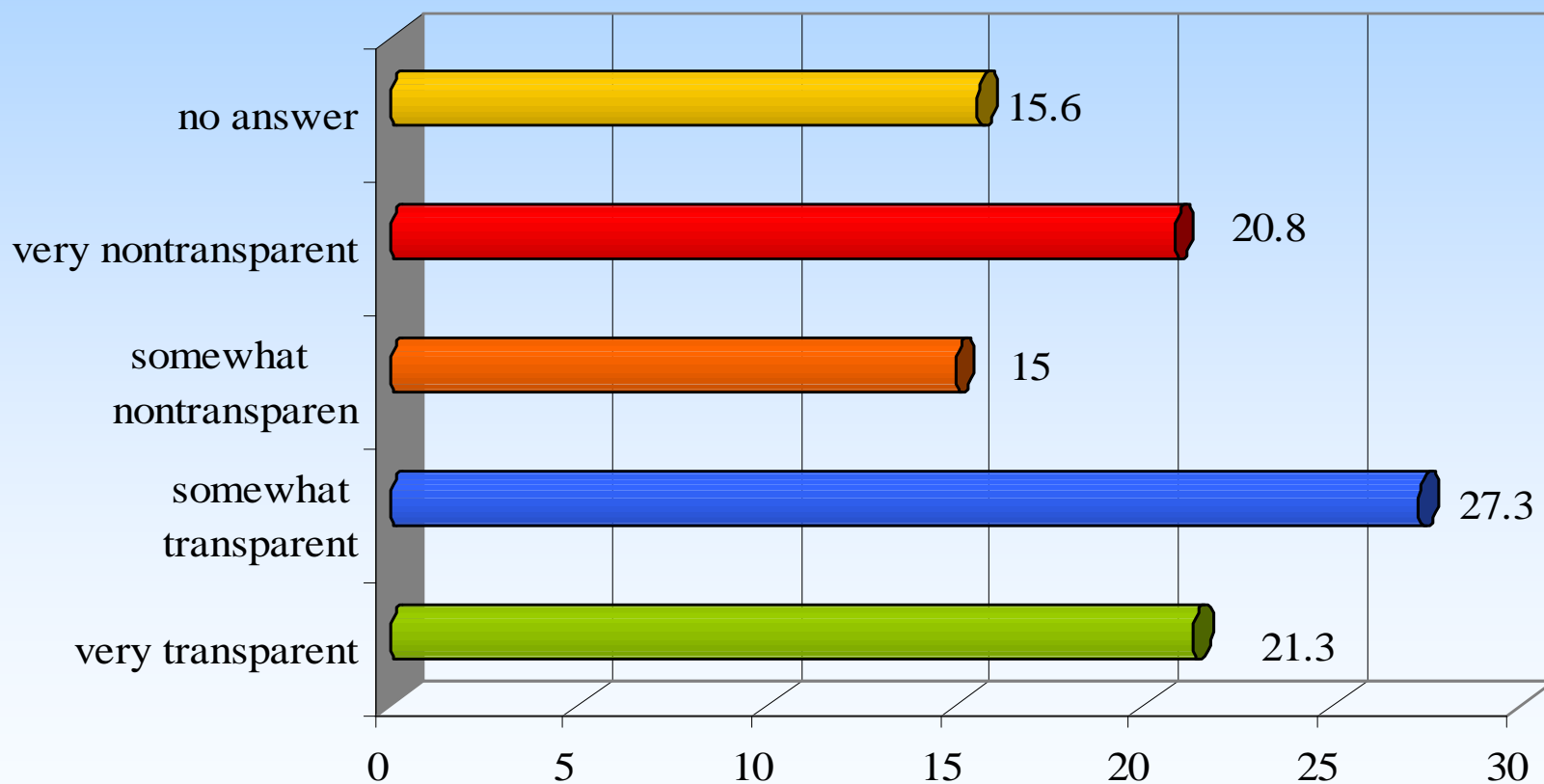
**Do you consider that, with its actions and behavior, the local Government is transparent or nontransparent?**

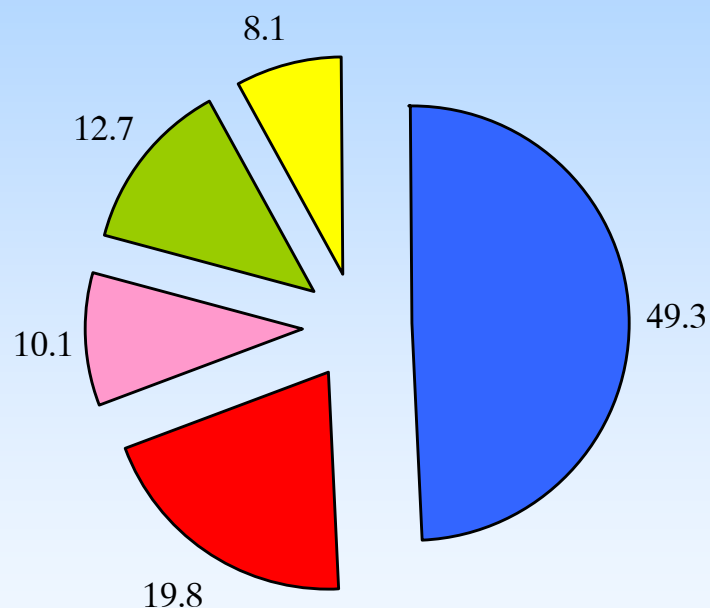

## Generally speaking, how important is the public (free) access to Governmental documents and information for good governance?

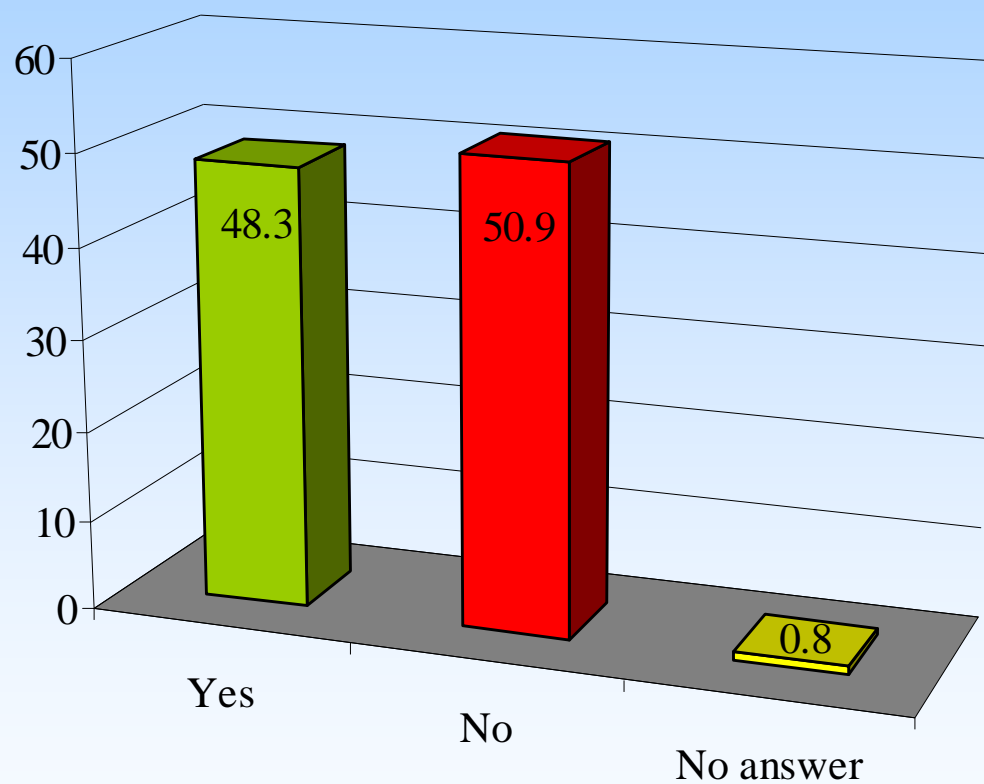


- Very important for good governance

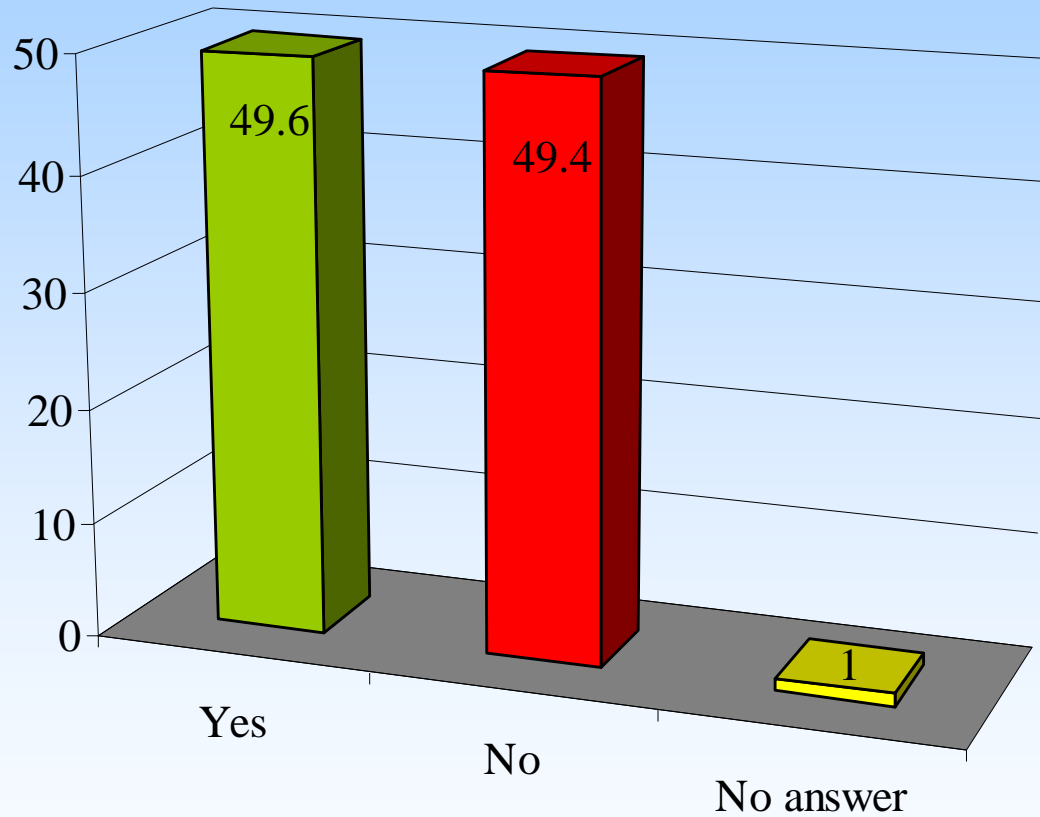

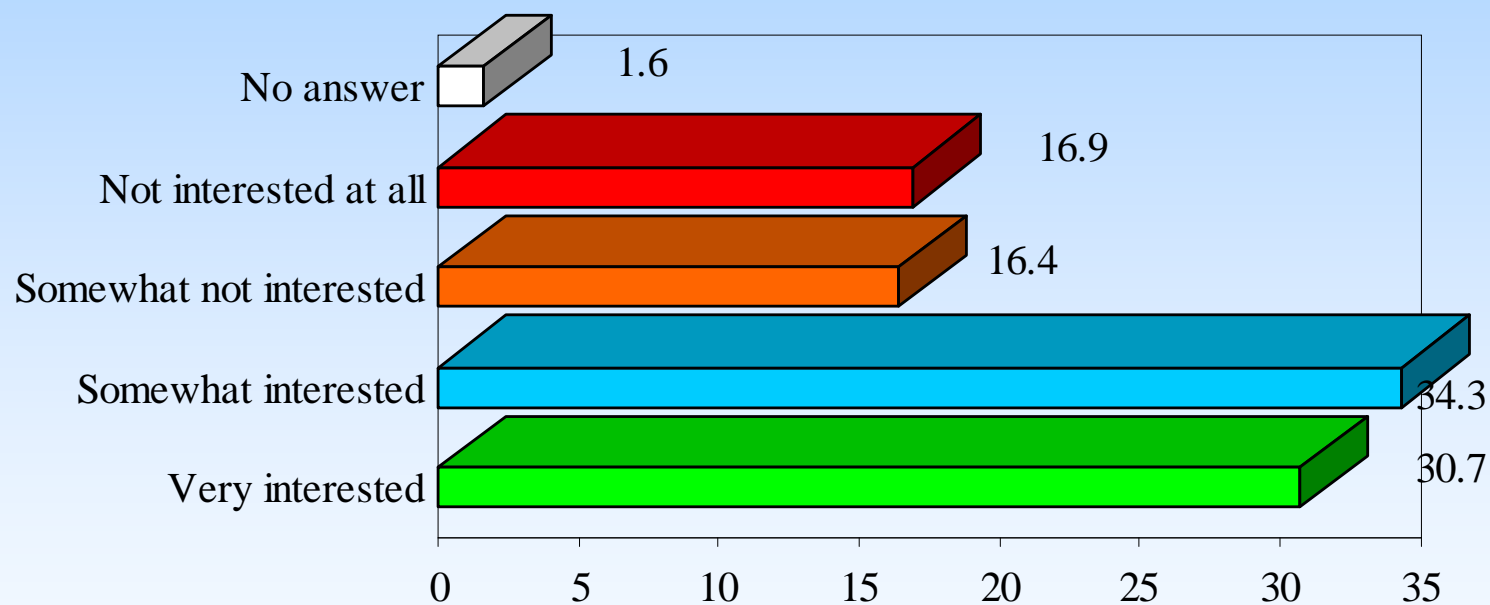
## Would you like to attend, as an observer, the work of the Government?

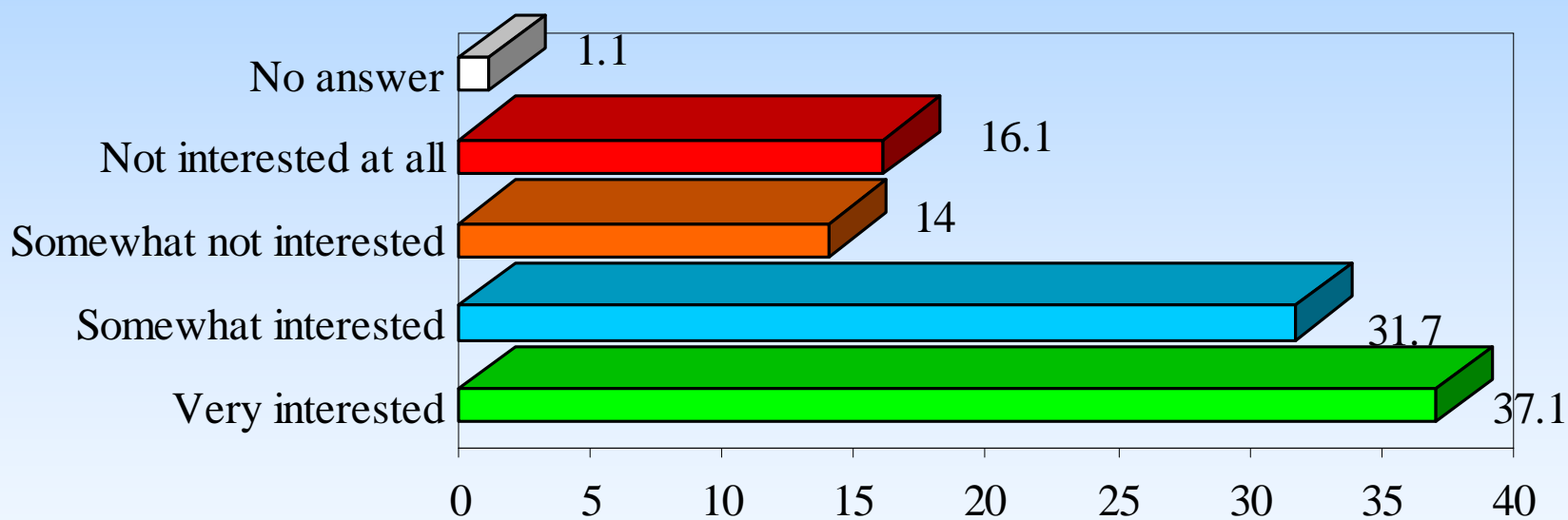
## How interested are you in the various activities of your local Government?





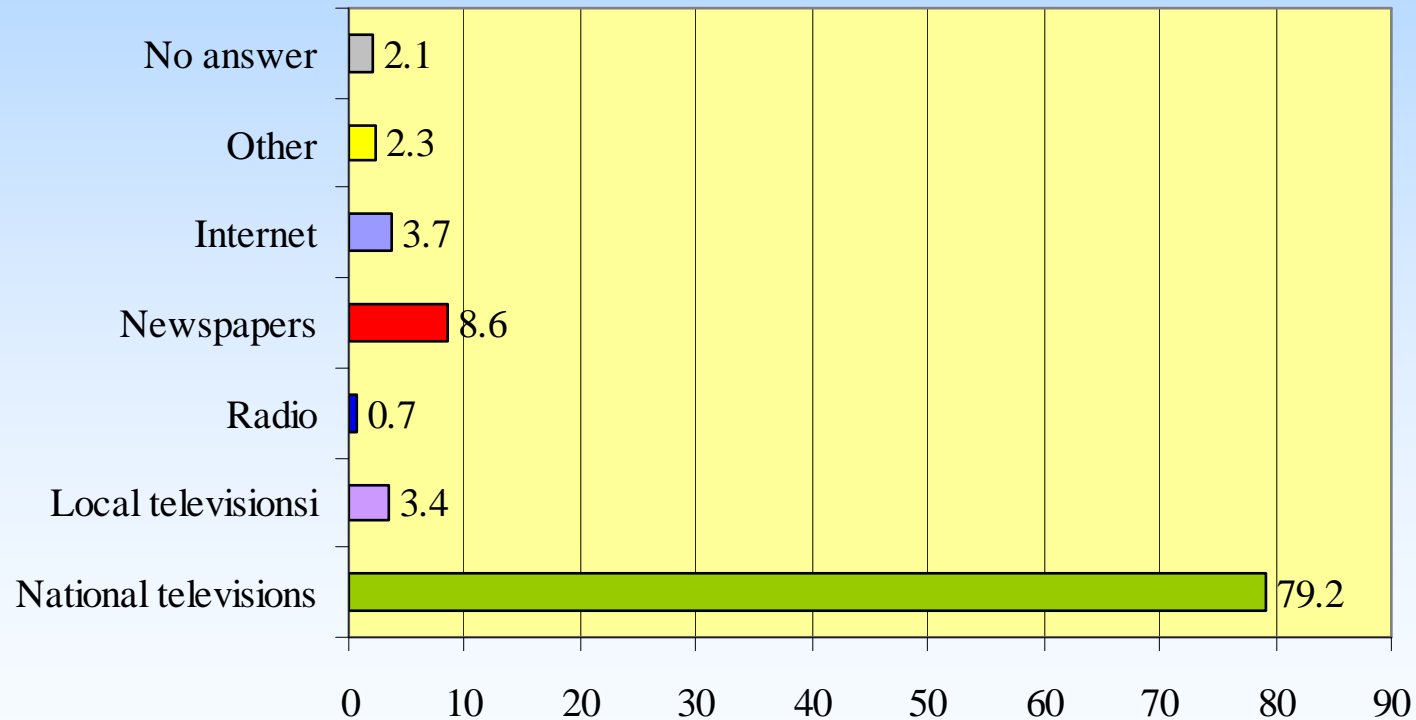

## How interested are you in the various activities of the Government?





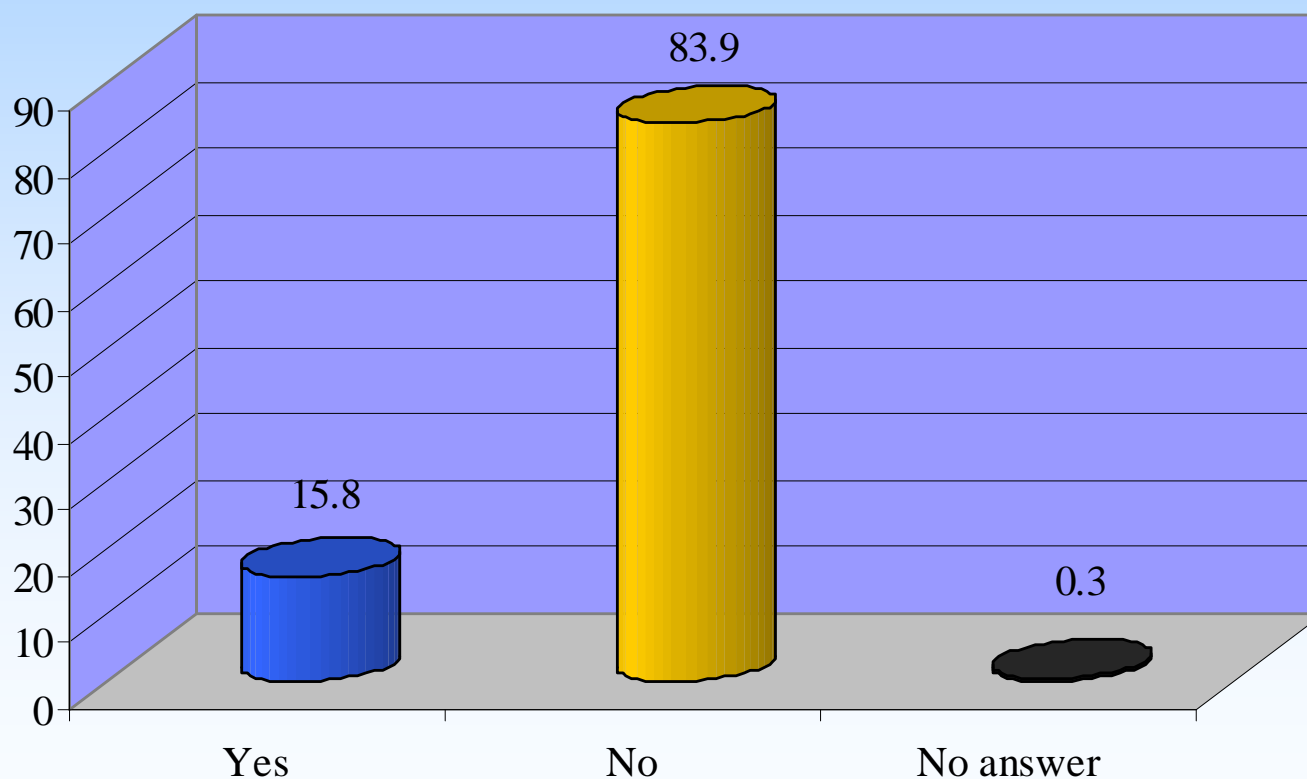
## Where you usually receive the information from, about the Government and the local institutions?

**Sometimes citizens seek information from official government records, issued by the Government or the local institutions. Have you ever requested such document?**

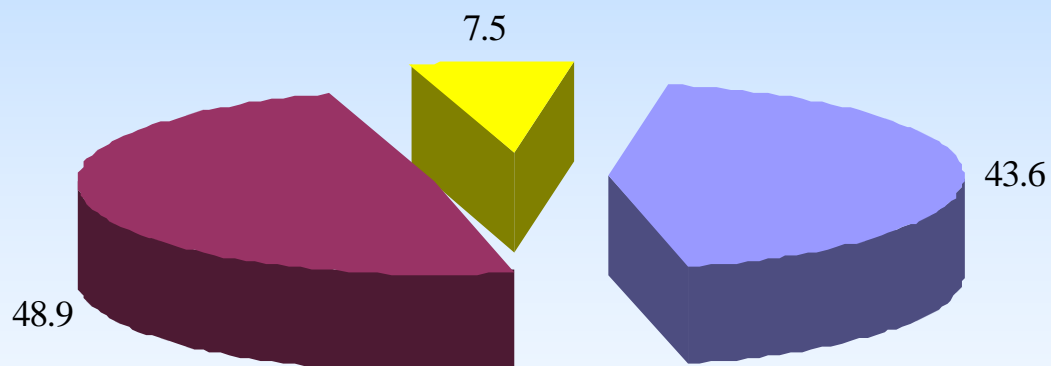

**Do you consider that all Governmental records should be open to public (with exception of documents important for the national security), or they should be open only if the citizens can make sound legal case?**

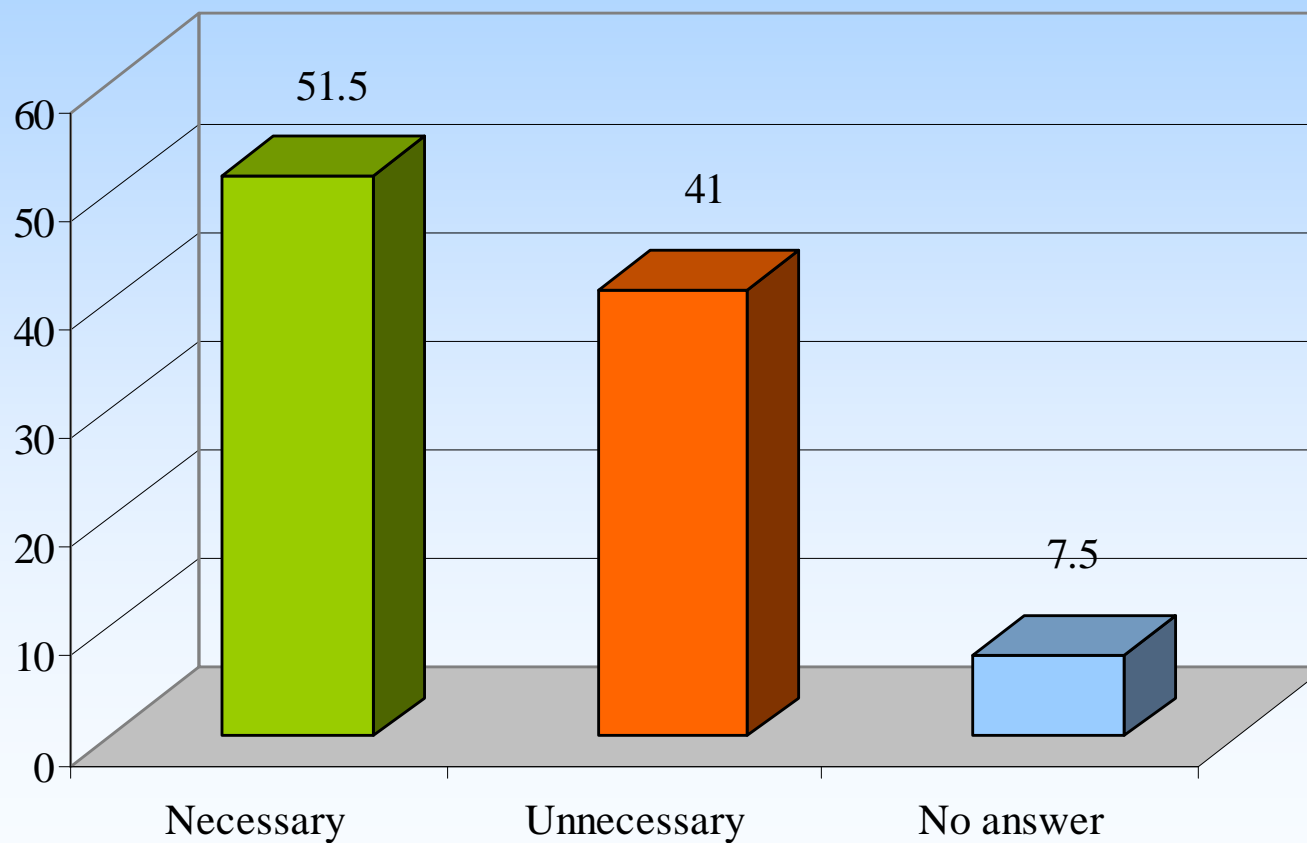
